## **Indology Quiz Competition:**

Description: A scholarly challenge designed to test participants' mastery of Indian intellectual traditions through an in-depth quiz based on two seminal texts: *Samvadasamgrahah and Indian Contributions to Science*. The competition aims to illuminate the richness of India's cultural and philosophical legacy.

**Eligibility:** Students (Age 18+) and General Public (Age 18+) aimed at encouraging young scholars and students. Inclusive for lifelong learners, independent researchers, professors etc.

## **Quiz Structure**:

- **Round-1** (**Online**): Preliminary round with multiple-choice questions will be based on *Samvadasamgrahah* and *Indian Contributions to Science*. Online quiz starts from: 25/10/2025, *Time:* 4:00 PM; Deadline:31/10/2025, *Time:* 4:00 PM. The participants may participate in the quiz competition anytime at their convenience between the above-mentioned dates. The Quiz duration will be 10 min containing 100 questions with Negative marking. The list of shortlisted candidates will be announced by 2<sup>nd</sup> Nov 2025. Top 10 Candidates will be shortlisted for the next Round (5 more candidates will be kept waitlisted).
- **Round-2** (**Offline**): Final round will be held on **20th November 2025** with deeper understanding of the texts, based on *Samvadasamgrahah* and *Indian Contributions to Science and 16 Thematic Areas of IKS (link)* at the conclave venue, featuring live buzzer rounds, rapid-fire questions. Finalists must be present at the conclave venue on the morning of 20th November 2025.
